

In the exercise of the powers conferred upon me by section 5(2) of the Constitution of the Federal Republic of Nigeria (as amended); section 127 of Sokoto State Revenue Integration and Consolidation Law No. 3 2019 and all other powers enabling me in that behalf, I, **Ahmed Aliyu Sokoto P.hD. FCNA**, Executive Governor of Sokoto State of Nigeria do hereby make the following Order:

1. **This Order may be cited as Sokoto State Revenue Integration and Consolidation (Consolidated Demand Notice Review) Order (NO. 5) 2023 and shall be deemed to have come into force on theday of December 2023.**
2. **For the purpose of making direct investment in the State easier the following Order is hereby made:**
 - a. **The Consolidated Demand Notice made in pursuance of the First Schedule to Sokoto State Revenue Integration and Consolidation Law No. 3 2019 is hereby reviewed and replaced with the one appearing in the Schedule to this Order.**
3. **This Executive Order shall take effect immediately.**
